



## RULES & REGULATIONS

## General Club Rules

These Rules and Regulations are intended to be a guide to the use and enjoyment of the Peak Club. They are not intended to deal with all conceivable issues that may be presented for governance. These Rules and Regulations are established by the Peak Club to protect China Peak facilities and to promote the health, safety, welfare and enjoyment of the members. The Peak Club is committed to providing all members with an enjoyable club experience. To uphold these standards, members are expected to act in a manner consistent with good taste. The Peak Club may amend these Rules and Regulations from time to time as it determines appropriate in its sole discretion.

- 1) Members, their families and their guests shall abide by all rules and regulations of the Peak Club as they may be amended from time to time.
- 2) Members shall not use the roster or list of members of the Peak Club for solicitation or commercial purposes or distribute the roster to anyone other than a member.
- 3) Members shall not request special personal services from employees of China Peak who are on duty.
- 4) All complaints, criticisms or suggestions of any kind relating to any of the operations of China Peak or the Peak Club or its employees must be in writing, signed and addressed to the President of the Peak Club, LLC.
- 5) Peak Club members using the Peak Club Preferred Parking area shall follow the directions of the Peak Club Preferred Parking attendant. In the event the Peak Club Preferred Parking area is full, Peak Club members shall follow the directions of the China Peak parking staff for alternative parking.
- 6) On busy days a separate and signed Peak Club member lane will be established on most if not all chair lifts. In the event a Peak Club member lane is not set up, members shall use the regular maze lanes.
- 7) Members may not abuse any of China Peak's staff members, verbally or otherwise. All staff members who are performing duties to benefit Peak Club members are under the supervision of China Peak management and no member shall reprimand or discipline any staff member.

- 8) Violation of any Peak Club rules or conduct in a manner prejudicial to the best interests of Peak Club members will subject the person in violation to disciplinary action by the Peak Club in accordance with these Rules and Regulations.
- 9) The staff members of China Peak will have full authority to enforce these Rules and Regulations and any infractions will be reported to the management of China Peak.
- 10) In no event shall the Peak Club discriminate against any individual because of the individual's race, color, religion, sex, national origin, age, handicap or marital status.

### Membership Cards

- 1) The Peak Club will issue a membership card to each member that is eligible for membership benefits. Membership cards will include the member's name, Peak Club account number and type of membership (individual, couple, family, corporate). Peak Club members must have their Peak Club membership cards with them at all times while taking advantage of Peak Club benefits.
- 2) In order to protect China Peak from improper use of Peak Club benefits, membership cards must be presented at the point of sale for all transactions.
- 3) Peak Club membership cards will be mailed to the members at the address designated by the member or held for pick up at the Peak Club membership office at China Peak.
- 4) In the event of a lost or stolen membership card, the Peak Club must be notified immediately. The Peak Club will issue a new membership card and number.
- 5) Each Peak Club member may receive such identification decals and other insignia as the Peak Club may from time to time designate, and shall display such insignia as required by the Peak Club.

### Member Charges

- 1) The Peak Club may, at its discretion, establish a Peak Club account system or arrange through a bank or credit card company to issue to qualified Peak Club members, a credit card through which Peak Club charges for food, services or merchandise may be billed.

The Peak Club shall establish rules and regulations governing club accounts or Peak Club credit cards if such a system is established.
